TERMS OF USE:

Dyes and inks

The dyes used have a heavy metal content (Barium, Cobalt, Copper, Iron, Lithium, Manganese, Zinc, Lead, Cadmium and Mercury) lower than the percentages defined by regulation 1935/2004 and EU 10/2011.
